

Terms of reference to develop a documentary for the PHCU interventions in the project area (Kibaale; Maisuka HCIII, Kikuube; Kasonga HCIII, Kyegegwa; Mpara HCIV, Kasese; Mahango HCIII).

1.0 Background

Environmental Alert (EA) and <u>Südwind</u> are implementing a joint project titled, "<u>emPower Health Care in</u> <u>Uganda Project</u>" (PHCU). The project aimed to support health centres in hard-to-reach areas and refugee settlements in Uganda – within the Albertine rift – that are faced with energy access limitations, which compromise the effective delivery of health services to some of the hard-to-reach communities

To date, all the PHCU project planned activities in the four districts have been successfully implemented. , pending evaluation. As a sustainability model, EA would like to document the field experiences by developing and documenting recommendations, which will guide in resource mobilization.

- 1. Engagement with the four district Local Government officials; the CAO, DHO, DHRO and the RDC.
- 2. Energy needs assessment in Kasonga HCII and maisuka HCIII, Mpara HCIV and Mahango HCIII.
- 3. Provision of WASH requirements for the four health centers.
- 4. IECs development under reproductive health, sanitation and hygiene, Nutrition, and Covid-19 sops.
- 5. Validation of the IECs
- 6. Community interactions on family planning and hygiene.
- 7. VHT training
- 8. Awareness and advocacy engagement on Renewable Energy.
- 9. Radio talk shows on sanitation and hygiene, reproductive health and nutrition.
- 10. National project launch
- 11. Signing of MOUs with different stakeholders; 4 DLGs, the 4 health centres and KCSON.
- 12. Solar installation at Kasonga and Maisuka health centres and solar security lights for Mahango and Mpara HCs.
- 13. Youth training on Solar Operation Maintenance and Repair.
- 14. The Tricycle/ baby ambulance for Mahango Health Centre.
- 15. Vulnerable community group training on Livelihood support and support machines given to them.

EA has had engagements with different stakeholders in Kibaale and Kikuube District local government, Ministry of Health, the Ministry of Energy and mineral development, Kyangwali and Kyakazihire communities, and Kasonga and Maisuka health centers. EA with interns to document her experiences highlighting key messages on the benefits of Renewable energy to improve health service delivery.

It is for this reason that Environmental Alert is seeking for a professional service provider to produce a documentary on the project interventions based on the project expectation and highlight communication concerns, opportunities, achievements, and gaps that call for further engagements.
