

# **Environmental Alert's Profile**

Environmental Alert (EA) was founded in 1988 and has contributed to improved livelihoods and development in Uganda through several interventions in four thematic areas: Sustainable Agriculture; Water, Sanitation and Hygiene (WASH); Environment and Natural Resources Management (ENR) and Climate Action/Climate Change. Gender and social inclusion is a cross-cutting theme across the four thematic areas. EA is officially registered with the NGO Bureau as a Ugandan non- governmental organization, incorporated as a company limited by guarantee. EA is governed by an independent Board of Directors that is responsible for providing strategic oversight of the organization including ensuring its integrity as a voluntary service organization.

This brief profile presents more information about EA's competences, experiences and achievements over the years.

**Vision-** 'Resilient and dignified communities, managing their environment and natural resources sustainably.'

**Mission** – '*EA exists to advocate for an enabling environment, sustainable natural resources management and food security for targeted communities through empowerment and policy engagement.'* 

To accomplish its mission, EA specializes in policy engagement for better policies and delivery of services to poor communities in both rural and urban environments. EA undertakes structured service delivery mobilizing communities and facilitating development of their skills, approaches and technologies for the sustainable management of their agricultural systems, natural resources and Water, sanitation and hygiene (WASH) facilities and services. We generate experiences, lessons and facts which inform EA's issue-based advocacy agenda at the community, local, national and international levels.

EA is also host of the Secretariat of major national CSO Networks, which provides opportunity for mobilisation and coordinating stakeholders for issue-based advocacy, lobbying and policy influencing as well as uptake and scale up of good practices in the specific areas of focus. To achieve our goal EA works with Ministries, Departments and Agencies (MDAs) such as Ministry of Water and Environment-MWE; Ministry of Agriculture, Animal Industry and Fisheries-MAAIF; Ministry of Energy and Mineral Development-MEMD; National Environment Management Authority-NEMA; District Local Governments-DLGs at the decentralised level; private sector agencies; and with Network members in the different regions of the country.

# EA operations and outreach

EA scale of engagements currently involves stakeholders in **40 districts across the country** (i.e., 20 in the Albertine graben) -- *Arua, Nebbi, Koboko, Moyo, Adjumani, Yumbe, Maracha, Hoima, Buliisa, Kagadi, Kibaale, Kasese, Bushenyi, Rubirizi, Mitooma, Rukingiri, Kabarole, Kabale, Kisoro, Bundibugyo, Ntoroko, Kyotera and Rakai*); Kampala, Kamwenge, Kyegegwa, Kyenjojo, Wakiso, Mukono, Jinja, Bududa, Katakwi, Amudat, Buikwe, Luweero, Isingiro, Rakai, Kyegegwa, Gulu and Masindi.

EA as a host for Secretariat of major national CSO networks has vast experiences in mobilizing and coordinating over 250 CSOs/CBOs for joint action and issue-based policy engagement at national and local levels in the agriculture; environment; natural resources; water, sanitation and hygiene (WASH) and renewable energy sectors. EA achieved this through CSO Networks such as Uganda Forest Working Group - http://ufwg.envalert.org/; Standards Development Group; Environment and Natural Resources -CSO Network - http://enr-cso.org/; PROLINNOVA- Uganda Network - http://www.prolinnova.net/uganda; and Renewable Energy CSO Network in Uganda – <a href="https://recso-network.org/">https://recso-network.org/</a>. EA also hosts and coordinates the Running Out Of Trees (ROOTs) Campaign on behalf of the Ministry of Water and Environment (MWE).

Therefore, EA has played and continues to play a representation and leadership role in structured CSO lobbying and advocacy engagements at the national, sub-regional and local levels.

The following are some of sector spaces where EA participates: EA is a member of the National *Wetlands Advisory Group;* a members of the Green Climate Fund (GCF) Wetlands Restoration Project Steering Committee chaired by the Ministry of Water and Environment (MWE); the National REDD+1 Technical Committee; the Technical Committee of the Agroforestry & Urban Forestry Sub-forum of the National Forestry Forum; and the Environment and Natural Resources Sector Working Group for the Ministry of Water and Environment.

<sup>4</sup> Renewable Energy CSO Network (RECSO) is a loose semi-formal Network that brings together civil society organizations, academic institutions, individuals and Networks engaged in the promotion and development of activities and practices in the Renewable energy sub sector at all levels (i.e. national, local, sub-regional and community). This process started September 2017 with the identification, mapping and profiling of the CSOs and Networks in renewable energy for purposes of potential partnerships and effective coordination. **Running Out Of Trees (ROOTs) Campaign** – Uganda has lost more than 23% of its tree cover between 2000 and 2020 (Global Forest Watch). Forest cover has declined from 3,786,547 ha in 2000 to 2,729,159 ha , a loss of 1,057,388 ha (equivalent to 28%). The overall annual deforestation rate between 2000 and 2019 was 55,652 ha, a deforestation rate of 1.5% annually. Deforestation has led to an average annual emission of 20.8 metric tons of greenhouse gases, resulting in a total release of 438 metric tons of carbon dioxide during the same period. Climate change, with its severe effects including extreme weather events such as droughts, floods, and landslides, has resulted in substantial loss of lives and property. Therefore, to contribute to reversing this situation, the Ministry of Water and Environment and partners are implementing a nation-wide tree planting initiative called ROOTs, through which the Government of Uganda aspires to restore forest cover to 24% of the country's total land area by 2030. The campaign aims to plant one tree for every Ugandan annually, i.e. up to **40 million Trees per Year."** EA hosts and currently acts as the Secretariat for the ROOTs Campaign.
